OSHA Training Institute (OTI) Education Centers

The OSHA Training Institute (OTI) Education Centers are a national network of nonprofit organizations authorized by OSHA to deliver occupational safety and health training to private sector workers, supervisors, and employers. These organizations are selected through a competitive process based on their occupational safety and health training experience and receive no funding from OSHA. The OTI Education Centers offer courses and seminars on various safety and health topics. Also, they support the OSHA training mission through other safety and health programs including community outreach efforts, safety stand-downs, courses offered in Spanish, and various youth initiatives. The OTI Education Centers help ensure safe and healthful working conditions by providing hazard recognition and avoidance training to workers, employers, and safety professionals.

Program Background

The OTI Education Centers Program was created to meet the growing demand for private sector training at the OSHA Training Institute (OTI) in Arlington Heights, Illinois. OTI Education Centers provide training for private and public sector personnel and personnel from Federal agencies other than OSHA. The OTI Education Centers offer courses developed by OSHA to inform employers and their employees about common safety and health hazards in the workplace. The program began with four organizations selected in 1992.

Program Growth


From four OTI Education Centers in 1992, the Program realized continued growth, expanding to include at least one OTI Education Center in each OSHA region. Who Should Attend Courses?

OTI Education Centers offer training courses designed for workers, employers, supervisors, and managers in all industries. Training is provided through an open enrollment format and on a contract basis for organizations within OSHA's jurisdiction.
