FedWeek Enrollment Instructions:

1. Students should complete the “OSHA FEDWeek Enrollment Request Form” to request enrollment into the FedWeek seminars they are interested in attending.
2. When a seminar is full, students cannot be enrolled. There are maximum registrations set by the OSHA Training Institute, which cannot be exceeded. If students request enrollment for a seminar that is full, they will be added to a waitlist. Students will receive either a registration or waitlist notification.
3. Students should not make travel arrangements unless they receive a registration notification.
4. Enrollments are on a first come, first serve basis. Students may not get enrolled if other requests were submitted before theirs.
5. Students will only be allowed to attend the sessions that they are enrolled in. No “walk-ins” will be allowed.
