#### Citation 1 Item 1 Type of Violation: **Willful**

29 CFR 1926.501(b)(13): Employee(s) engaged in residential construction activities 6 feet (1.8 m) or more above lower levels are not protected by guardrail systems, safety net system, or personal fall arrest system, nor are employee(s) provided with an alternative fall protection measure under another provision of paragraph 1926.501 (b):

a. Employees performing sheathing work from a 5:12 pitch roof are not being protected from 11 feet and higher fall hazards by a fall protection system.

The employer routinely fails to assure effective protection against falls as required by the standard, as demonstrated on October 26, 2017, when employees are sheathing a roof of a two-story residential building at Lot 67/68 Lucena Lane, Jacksonville, Florida without fall protections and are exposed to fall hazard of 11 feet above the surrounding ground.

Desouza Framing Inc. was previously cited for a repeat violation of this occupational safety and health standard or its equivalent standard, 1926.501(b)(13), which was contained in OSHA inspection number 943936, citation number 2, item number 2 and was affirmed as final order on December 9, 2013, with respect to a workplace located at 437 Forest Meadow Lanelot 693, Orange Park, Florida.

Desouza Framing Inc. was previously cited for a repeat violation of this occupational safety and health standard or its equivalent standard, 1926.501(b)(13), which was contained in OSHA inspection number 955071, citation number 1, item number 2 and was affirmed as final order on April 29, 2014, with respect to a workplace located at 4310 Eagle Landing Place, Middleburg, Florida.






Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

**Interest:** Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

**Delinquent Charges:** A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. 29 CFR 1926.501(b)(13): Employee(s) engaged in residential construction activities 6 feet (1.8 m) or more above lower levels are not protected by guardrail systems, safety net system, or personal fall arrest system, nor are employee(s) provided with an alternative fall protection measure under another provision of paragraph 1926.501(b):

a. Employees performing framing operations and other construction activities at elevations are not being protected from a 22-foot fall hazard by use of a fall protection system.

The employer routinely fails to assure effective protection against falls as required by the standard, as demonstrated on December 18, 2017, when employees are sheathing a roof of a two-story residential building at 1559 Orange Branch Trail, Saint John's Florida without fall protections and are exposed to fall hazards of 22 foot interior and 11 foot exterior at the eave.

Desouza Framing Inc. was previously cited for a repeat violation of this occupational safety and health standard or its equivalent standard, 1926.501(b)(13), which was contained in OSHA inspection number 943936, citation number 2, item number 2 and was affirmed as final order on December 9, 2013, with respect to a workplace located at 437 Forest Meadow Lane lot 693, Orange Park, Florida.

Desouza Framing Inc. was previously cited for a repeat violation of this occupational safety and health standard or its equivalent standard, 1926.501(b)(13), which was contained in OSHA inspection number 955071, citation number 1, item number 2 and was affirmed as final order on April 29, 2014, with respect to a workplace located at 4310 Eagle Landing Place, Middleburg, Florida.

Desouza Framing Inc. was previously cited for a repeat violation of this occupational safety and health standard or its equivalent standard, 1926.501(b)(13), which was contained in OSHA inspection number 980402, citation number 1, item number 2 and was affirmed as final order on September 8, 2014, with respect to a workplace located at Lot 406 South Torwood Dr., Saint Johns, FL 32259.

To abate this violation, the employer must ensure that all employees wear appropriate fall protection or install a guardrail or safety net system when an employee works 6 feet or more above the lower surface. Pursuant to 29 CFR 1903.19, the employer must submit documents describing the steps it is




If a personal check is issued, it will be converted into an electronic fund transfer (EFT). This means that our bank will copy your check and use the account information on it to electronically debit your account for the amount of the check. The debit from your account will then usually occur within 24 hours and will be shown on your regular account statement. You will not receive your original check back. The bank will destroy your original check, but will keep a copy of it. If the EFT cannot be completed because of insufficient funds or closed account, the bank will attempt to make the transfer up to 2 times.

Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

**Interest:** Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

**Delinquent Charges:** A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

**Administrative Costs:** Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt.
