

PERFORMING ARTS AND MOTION PICTURE HAZARD INFORMATION

Work in performing arts and motion pictures, including spectator sports, sound recording, and related industries, can be dangerous. In 2016, there were **57 fatal injuries** and **5,570 estimated nonfatal injuries and illnesses, resulting in days away from work**, among this industry (U.S. Bureau of Labor Statistics). Finding and fixing hazards ensures workers go home safe and sound every day. Use the information below to find and fix hazards in your workplace.

Performing Arts and Motion Picture Industries

Fatal Events

- Transportation incidents, including roadway and non-roadway motor vehicles
- Violence and other injuries by persons or animals
- Fires and explosions
- Exposure to harmful substances or environments

Nonfatal Events

- Overexertion in lifting or lowering and repetitive motion work
- Falls, slips, trips
- Contact with object and equipment
- Violence and other injuries by persons or animals
- Transportation incidents
