Training and Education

- The site continues to administer the OSHA General Industry and Construction 10 hour training courses to Center students.
- The Safety/Security Manager and/or the Safety Officer provided staff and students with the following training sessions during this period:
 - a) Personal Protective Equipment/Weekly with Employees
 - b) Slips, Trips and Falls: Stronger than Friction/Weekly with Employees/Monthly with Staff
 - c) Office Safety: Quarterly Training
 - d) GSA Vehicle Safety Orientation and Van Road Test/With all New Employees
 - e) The Safe Operation of Utility Cars
 - f) Zero Fatalities: Texting and Driving

Outreach and Communication

- Mr. Jacinto Ramos attended OSHA's El Paso Area Office New Recordkeeping and Reporting Requirements presentation at T&T Staff Management on March 24, 2015, presented by CAS Abraham Arzola.
- Mr. Jacinto Ramos attended the free UTA Bloodborne Pathogens class at T&T Staff Management scheduled in observance of Workers' Memorial Day. OSHA's El Paso Area Office provided outreach during this training session.
- Mr. Jacinto Ramos attended OSHA's El Paso Area Office National Fall Prevention Stand-Down presentation at T&T Staff Management on May 14, 2015, presented by CAS Abraham Arzola.

Promoting the National Dialogue on Workplace Safety and Health

- The Center continues to established policies and procedures to promote a safe environment in the workplace.
- The Safety and Occupational Health Committee holds monthly meetings to report and eliminate any potential safety hazards, including a walkthrough of the Center performed by students who report any safety concerns for corrective action.
- An independent contractor conducts annual Environmental inspections of the Career Technical Training Trades, Academic Education, and Social Development areas, including the swimming pool.
- The City of El Paso Public Health department conducts monthly inspections of the Food Service Department.

- The Center conducts monthly Fire Drills.
- The Safety Officer conducts daily Environmental and Safety walkthroughs of Center premises reporting any deficiencies for corrective action to the appropriate department heads.
- The Safety & Security Manager provides new staff and students with safety orientation training including Center policies and procedures, fire prevention and bloodborne pathogens. Staff also receives training in Office safety.
- The Safety Officer ensures that the annual licensing of fire alarms is done.
- The City of El Paso Fire Department conducts random inspections to ensure the Center is in compliance with city ordinances.
- The Safety and Security Department, in coordination with the Fire Department, conduct a semiannual live fire extinguishing activity for staff and students.
- A Pre-Survey Job Safety Analysis is conducted by the Safety Officer prior to the start of any projects on Center.
- Mr. Joel Hernandez, Safety Officer, has completed all required training in the Personnel Regulation Handbook and is meeting DOL/OSHA Standard requirements.
- Job Corps students participated in the Student Safety Survey and were compared with the National Center.
