Principal Deputy Assistant Secretary's Agency Update and Remarks:

Speaker: Ms. Loren Sweatt, Principal Deputy Assistant Secretary of Labor, OSHA

Ms. Sweatt began her presentation by thanking everyone on the ACCSH committee for their service and expressed her appreciation for the work that they do to support the agency. Ms. Sweatt went on to thank them for their commitment to the safety and health of the nation's construction workforce during the challenges presented by COVID-19. OSHA has worked hard to provide guidance, information, enforcement and response to complaints to ensure worker protection during the challenges presented by COVID-19. Ms. Sweatt highlighted OSHA's 50th Anniversary and reminded the committee of two upcoming events, "Safe + Sound Week 2020" scheduled to run August 10-16, 2020 and the Fall Stand-Down scheduled for September 14-18, 2020. Ms. Sweatt ended her presentation by asking everyone to visit OSHA.gov, sign up for the QuickTakes newsletter, and follow OSHA on Twitter for the latest news and information.

Directorate of Construction Update:

Speaker: Mr. Scott Ketcham, Director, Directorate of Construction, OSHA

Mr. Ketcham welcomed everyone in attendance to the meeting and noted that it had been a year since the last full ACCSH meeting. Mr. Ketcham presented a detailed update on issues pertinent to the directorate's current focus and provided an overview of completed and ongoing projects & activities. It included an overview of OSHA's work with the CDC, NIOSH, other federal agencies, and stakeholder groups, to share the latest information on COVID-19; a breakdown of how the Directorate of Construction (DOC) is organized with a quick description of each offices responsibilities; the top 10 violations in construction and the Focus Four Hazards where falls are still the leading injury producer; a regulatory update which include technical corrections to OSHA standards, rail road cranes, communication towers, welding in confined spaces, crane operator certification, and PPE fit in construction. OSHA has three directives nearing completion of the clearance process: Crane Operator Certification, Excavation, and the Drone directives. Mr. Ketcham highlighted the upcoming safety awareness campaigns: Safe + Sound Week, the Fall Stand-Down and the Trench Safety Stand-Down and reminded everyone of the dates. He took questions from the committee and provided additional insight regarding items discussed in his presentation.

Directorate of Enforcement Programs (DEP) Update:

Mr. Rundman provided an update how OSHA is now using the Compliance Directive, CPL 02-02-080, *Inspection Procedures for the Respirable Crystalline Silica Standards*, published June 25, 2020 to enforce the *Respirable Crystalline Silica Standards*, 29 CFR 1910.1053 and 29 CFR 1926.1153. Mr. Rundman provided a

brief overview of sections of the directive, mentioned newly developed tools and FAQs to assist in compliance. He and then took questions from the committee and provided additional insight regarding items discussed in his presentation.

Proposed Rule to Update the Consensus Standards Incorporated by Reference for the Design and Construction Standards of Powered Industrial Trucks in Construction (29 CFR 1926.602):

Speakers: Mr. Ken Stevanus, Directorate of Standards and Guidance, Office of Engineering Safety, OSHA

Mr. Juan Lopez, Office of the Solicitor, U.S. Department of Labor

Mr. Stevanus presented the proposal that would update the consensus standards incorporated by reference to the powered industrial truck standards for both construction and general industry. The new consensus standards would specifically address the design and construction provisions of powered industrial trucks.

Mr. Stevanus and Mr. Lopez took questions from the committee and provided additional insight regarding items discussed in their presentation. Following the committee's discussion, ACCSH made a recommendation:

Motion: Chris Trahan Cain moved that ACCSH recommend that OSHA publishes the planned notice of proposed rulemaking, updating OSHA's construction standards for powered industrial trucks, 29 CFR 1926.602, related to the design and construction requirements of the standard.

Second: Ron Sokol. The motion passed unanimously.

Proposed Rule to Update the Hazard Communication Standard to align with the 7th Revision of the Global Harmonized Standard (GHS) Presentation:

Ms. Carter and her team presented a proposal to update the current Hazard Communication (HAZCOM) Standard to meet recent changes to the Global Harmonized Standard (GHS). She then provided some background on the previous efforts to align with the GHS and then discussed the proposed changes that would further align the HAZCOM Standard with the GHS. Ms. Holmes and Ms. Lawless then presented on the particular changes made to harmonize HAZCOM Standard with the GHS. Ms. Carter then provided closing comments and asked ACCSH for a recommendation to proceed with the Notice of Proposed Rulemaking to revise the Hazard Communication Standard and align with the established provision of the GHS. Ms. Carter, Ms. Holmes and Ms. Lawless took questions from the committee and provided additional insight regarding items discussed in their presentation. Following the committee's discussion, ACCSH made a recommendation:

Motion: Chris Fought moved that ACCSH recommend OSHA publish the planned Notice of Proposed Rulemaking to revise the hazard communication standard to align with the 7th Revision of the Global Harmonized System or GHS.

Second: Rich Tessier. The motion passed unanimously.

ACCSH Work Group Discussions

Education, Training and Outreach Workgroup Report:

Speakers: Ms. Christina Trahan Cain, Safety and Health Director, North America's Building Trades Unions

Mr. Fravel Combs, Corporate Manager EH&S, M.A. Mortenson Company

Ms. Cain opened and identified herself as co-chair with Mr. Combs. She then asked for several documents to be accepted into the record that include:

- Workgroup meeting notes from March 5, 2020
- Workgroup meeting notes from June 30, 2020
- Presentation from Mr. Rank from Ironworkers on Falls and Trip Hazards
- Presentation from Mr. Shanahan from National Roofing Contractors Association

Mr. Gilliland stated that the exhibits would be accepted into the record at the end of the meeting.

Ms. Cain explained that the workgroup was tasked to focus on three major issues: falls, trenching, and basic outreach activities for the construction industry. In the March meeting, OSHA's Directorate of Training and Education (DTE) provided the workgroup a presentation on the training they conduct falls and trenching safety. The workgroup also discussed the falls campaign and National Fall Stand-Down. Ms. Cain talked about the discussion concerning Appendix B of 29 CFR 1926, Sub-part L *"Scaffolds."* Ms. Cain mentioned that the work group had also received information from NUCA (National Utility Contractors Association) and NAXSA (North American Excavation Shoring Association) relating to trenching stand-downs and summits.

Ms. Cain gave a breakdown on the discussions conducted during the June 30, 2020 meeting that included: the impact of COVID-19 on the industry; two presentations on fall hazards; an update from the NORA (National Occupational Research Agenda) Construction Sector Council Falls Workgroup and this year's OSHA National Safety Stand-Down. DTE provided the workgroup an update on the effects of the pandemic on operations at DTE, and revisited topics from the March meeting. Ms. Cain asked that the workgroup be provided what the agency meant concerning adjustments that are being made to agency (OSHA) priority goals for trenching due to COVID-19 impacts.

Ms. Cain asked, due to a consensus of the workgroup, to discuss the topic of the impact of compliance directive CPL 02-01-048, *Clarification of OSHA's enforcement policies relating to floors/nets and shear connectors; Cancellation of CPL 02-01-046 (Sept. 30, 2009)* and May 21, 2012 Memo to Regional Administrators issued in

regards to 29 CFR 1926, Subpart R – Steel Erection. Ms. Cain asked for recommendations by the full ACCSH membership concerning the hazard concerns brought up by the workgroup.

Ms. Cain and Mr. Combs took questions from the committee and provided additional insight regarding items discussed in their presentation.

Motion: Chris Trahan Cain moved that ACCSH recommend that OSHA review, reconsider, and update the committee on CPL 02-01-048, issued April 30th 2010, and the memo to the regional administrators issued on May 21st, 2012, on steel erection.

Second: Randy Krocka. The motion passed unanimously.

Mr. Earnest then recognized his co-chair and the workgroup members. He then began his presentation with background information concerning the data on drug overdoses and opioids and suicides in the construction industry. Mr. Earnest then recapped the presentations provided to the workgroup which included information to develop possible recommendations for OSHA on: the development of a special emphasis program; outreach training development; and development of leading indicators to track.

Mr. Earnest and Mr. Sizemore took questions and continued the discussion of points made in the presentation from the committee and provided additional insight regarding items discussed in their presentation. Mr. Earnest then asked for more time, from Mr. Cannon, to continue to develop ideas in the workgroup before making a recommendation to the full ACCSH.

Public Comment:

Steve Rank, Public Commenter #1

Mr. Rank asked that ACCSH reaffirm their 2011 unanimous vote to have OSHA pursue and revise 29 CFR 1926, Subpart Q, *Concrete and Masonry Construction* standard due fatalities in the reinforcing steel and post-tensioning industries. Mr. Rank mentions that ANSI, in 2013, passed a consensus standard that addressed the concerns presented to the ACCSH in 2011 and was reaffirmed in 2018. These changes have been passed in state plans for California and Washington. He states that the current standard is out-of-date and does not adequately cover operations. He then thanked the group for allowing him to present.

Motion: Chris Trahan Cain moved that ACCSH reaffirm the July 28, 2011 unanimous ACCSH vote recommending OSHA include in the fall regulatory 2020 agenda rulemaking for the revision of the existing 1926 Subpart Q Concrete Masonry Standard to incorporate reinforcing steel and post-tensioning standards contained in the 2018 ANSI A10.9 Concrete and Masonry Standard and subsequently adopted by California OSHA and Washington OSHA.

Second: Chris Fought

Chris Trahan Cain moved to amend her motion. She moved that ACCSH reaffirm the July 28, 2011 unanimous vote recommending OSHA conduct rulemaking and to include in the fall 2020 regulatory agenda rulemaking for the revision of the existing 1926 Subpart Q Concrete Masonry Standard and to incorporate reinforcing steel and post-tensioning standards contained in the 2018 ANSI A10.9 Concrete and Masonry Standard and subsequently adopted by California OSHA and Washington OSHA.

The motion to amend passed unanimously.

The vote on the main motion was 7 in favor, 5 oppose, and 3 abstentions. The motion failed.

Motion: Fravel Combs moved that OSHA provide an update on the Subpart Q progress since the 2011 committee and report out at our next full committee meeting.

Second: Chris Cain. The motion passed unanimously.

Ms. Cain requested that that the committee voting rules be provided to the committee, Mr. Gilliland said he would send them out to the committee members.

Mr. Fred Codding, Executive Vice President of the National Association of Reinforcing Steel Contractors, Public Commenter #2

Mr. Codding was delayed by technical difficulties getting into the meeting. Mr. Codding introduced himself and that his association worked with a coalition of interested parties in 2010 and 2011 to push for updating 29 CFR 1926, Subpart Q, specifically under the reinforcing steel and post-tensioning part of the standard. Stated he was astonished that OSHA did not follow through on adopting the updates due to the dangers workers are exposed to in the field. He had come to ask for support by the ACCSH members for this initiative and was happy to see that it was addressed today. Mr. Codding then closed by thanking the ACCSH committee for their time.
