*The violation(s) described in this Citation and Notification of Penalty is (are) alleged to have occurred on or about the day(s) the inspection was made unless otherwise indicated within the description given below.*

This Citation and Notification of Penalty (this Citation) describes violations of the Occupational Safety and Health Act of 1970. The penalty(ies) listed herein is (are) based on these violations. You must abate the violations referred to in this Citation by the dates listed and pay the penalties proposed, unless within 15 working days (excluding weekends and Federal holidays) from your receipt of this Citation and Notification of Penalty **you either call to schedule an informal conference (see paragraph below) or** you mail a notice of contest to the U.S. Department of Labor Area Office at the address shown above. Please refer to the enclosed booklet (OSHA 3000) which outlines your rights and responsibilities and which should be read in conjunction with this form. Issuance of this Citation does not constitute a finding that a violation of the Act has occurred unless there is a failure to contest as provided for in the Act or, if contested, unless this Citation is affirmed by the Review Commission or a court.

**Posting** - The law requires that a copy of this Citation and Notification of Penalty be posted immediately in a prominent place at or near the location of the violation(s) cited herein, or, if it is not practicable because of the nature of the employer's operations, where it will be readily observable by all affected employees. This Citation must remain posted until the violation(s) cited herein has (have) been abated, or for 3 working days (excluding weekends and Federal holidays), whichever is longer.

**Informal Conference** - An informal conference is not required. However, if you wish to have such a conference you may request one with the Area Director during the 15 working day contest period. During such an informal conference you may present any evidence or views which you believe would support an adjustment to the citation(s) and/or penalty(ies).

If you are considering a request for an informal conference to discuss any issues related to this Citation and Notification of Penalty, you must take care to schedule it early enough to allow time to contest after the informal conference, should you decide to do so. Please keep in mind that a written letter of intent to contest must be submitted to the Area Director within 15 working days of your receipt of this Citation. The running of this contest period is not interrupted by an informal conference.

If you decide to request an informal conference, please complete, remove and post the Notice to Employees next to this Citation and Notification of Penalty as soon as the time, date, and place of the informal conference have been determined. Be sure to bring to the conference any and all supporting documentation of existing conditions as well as any abatement steps taken thus far. If conditions warrant, we can enter into an informal settlement agreement which amicably resolves this matter without litigation or contest.

**Right to Contest** – You have the right to contest this Citation and Notification of Penalty. You may contest all citation items or only individual items. You may also contest proposed penalties and/or abatement dates without contesting the underlying violations. **Unless you inform the Area Director in writing that you intend to contest the citation(s) and/or proposed penalty(ies) within 15 working days after receipt, the citation(s) and the proposed penalty(ies) will become a final order of the Occupational Safety and Health Review Commission and may not be reviewed by any court or agency.**

**Penalty Payment** – Penalties are due within 15 working days of receipt of this notification unless contested. (See the enclosed booklet and the additional information provided related to the Debt Collection Act of 1982.) Make your check or money order payable to “DOL-OSHA”. You will be required to enter your inspection number when making the payment. Payments can be made by credit card or Automated Clearing House (ACH) using your banking information. OSHA does not agree to any restrictions or conditions or endorsements put on any check, money order, or electronic payment for less than the full amount due, and will process the payments as if these restrictions or conditions do not exist.

**Notification of Corrective Action** – For each violation which you do not contest, you must provide ***abatement certification*** to the Area Director of the OSHA office issuing the citation and identified above. This abatement certification is to be provided by letter within 10 calendar days after each abatement date. Abatement certification includes the date and method of abatement. If the citation indicates that the violation was corrected during the inspection, no abatement certification is required for that item. The abatement certification letter must be posted at the location where the violation appeared and the corrective action took place or employees must otherwise be effectively informed about abatement activities. #### **Citation 1 Item 1**    Type of Violation: **Willful**

29 CFR 1926.451(b)(1)(i): Each platform unit (e.g., scaffold plank, fabricated plank, fabricated deck, or fabricated platform) shall be installed so that the space between adjacent units and the space between the platform and the uprights is no more than 1 inch (2.5 cm) wide.

a) The employer does not have each working level of a scaffold fully planked or decked so that the space between adjacent units and the space between the platforms and the uprights are not more than 1 inch wide. This violation was most recently observed at the side (north) and back (east) walls of the building at 1303 South 15th Street on or about March 20, 2014, where employees were working up to thirty-two (32) feet above ground on a scaffold which had gaps greater than 1 inch between the planks, and greater than 2 inches between the planks and the uprights. To abate this ongoing violation, the employer must ensure that the working levels of the fabricated frame scaffolds are fully planked and the space between the planks and the uprights is not greater than one inch wide.

#### **Citation 1 Item 2**    Type of Violation: **Willful**

29 CFR 1926.451(c)(1): Supported scaffolds with a height to base width (including outrigger supports, if used) ratio of more than four to one (4:1) shall be restrained from tipping by guying, tying, bracing, or equivalent means, as set forth in subparagraphs (i) -(iii) of this paragraph.

a) The employer does not restrain the fabricated frame scaffolding from tipping by guying, tying, bracing or equivalent means. This violation was most recently observed at the side (north) and back (east) walls of 1303 South 15th Street on or about March 20, 2014, where employees were performing stucco operations from a fabricated frame scaffold that was not restrained from tipping by installing guys, ties, and braces. The fabricated frame scaffold was approximately thirty-two (32) feet in height and five (5) feet in width thus the height to base ratio was greater than 6:1. To abate this ongoing violation, the employer must require the use of guying, tying, bracing, or equivalent means when the height to base ratio exceeds four to one (4:1).

#### **Citation 1 Item 3**    Type of Violation: **Willful**

29 CFR 1926.451(g)(1)(vii): Each employee on a scaffold, not otherwise specified in paragraphs (g)(1)(i) through (g)(1)(vi) of this section, more than 10 feet (3.1 m) above lower level shall be protected from falls by the use of personal fall arrest systems or guardrail systems meeting the requirements of paragraph (g)(4) of this section.

a) The employer does not require employees to use any form of personal fall arrest systems or the use of guardrail systems while performing stucco operations from a fabricated frame scaffold. This violation was most recently observed at the side (north) and back (east) walls of 1303 South 15th Street on or about March 20, 2014, where employees performing stucco operations on multiple levels including the 5th level of the fabricated frame scaffold were not protected from fall hazards of approximately thirty-two (32) feet by the use of personal fall arrest systems or guardrail systems. To abate this ongoing violation, the employer must provide and require the use of personal fall arrest systems or guardrail systems while employees are utilizing the working levels of the fabricated frame scaffold.

**Citation 2 Item 1**    Type of Violation: **Repeat**

29 CFR 1926.451(c)(2)(ii): Unstable objects shall not be used to support scaffolds or platform units.

a) The employer utilizes unstable objects to support an erected fabricated frame scaffold thus exposing employees to severe injuries from the collapse of the fabricated frame scaffold. This violation was most recently observed at the back (east side) of 1303 South 15th Street on or about March 20, 2014, where employees were performing stucco operations on the exterior walls of a residential building approximately 32 feet above ground from a fabricated frame scaffold that was supported by unstable objects. The legs of the scaffold were placed on two planks used as a bridge across a window well approximately six feet in depth without stable vertical or lateral support. To abate this ongoing violation, the employer must ensure that unstable objects are not used to support scaffolds.

29 CFR 1926.454(a): The employer did not have each employee who performed work while on a scaffold trained by a person qualified in the subject matter to recognize the hazards associated with the type of scaffold being used and to understand the procedures to control or minimize those hazards.

a) The employer does not provide training to employees working on fabricated frame scaffolds to recognize the hazards associated with the type of scaffold being used and to understand the procedures to control or minimize those hazards. To abate this ongoing violation, the employer must provide scaffold training to each employee who performs work while on a scaffold; such training must be provided by a person qualified in the subject matter to recognize the hazards associated with the type of scaffold being used and the procedures to control or minimize those hazards.



Pursuant to the Debt Collection Act of 1982 (Public Law 97-365) and regulations of the U.S. Department of Labor (29 CFR Part 20), the Occupational Safety and Health Administration is required to assess interest, delinquent charges, and administrative costs for the collection of delinquent penalty debts for violations of the Occupational Safety and Health Act.

**Interest:** Interest charges will be assessed at an annual rate determined by the Secretary of the Treasury on all penalty debt amounts not paid within one month (30 calendar days) of the date on which the debt amount becomes due and payable (penalty due date). The current interest rate is one percent (1%). Interest will accrue from the date on which the penalty amounts (as proposed or adjusted) become a final order of the Occupational Safety and Health Review Commission (that is, 15 working days from your receipt of the Citation and Notification of Penalty), unless you file a notice of contest. Interest charges will be waived if the full amount owed is paid within 30 calendar days of the final order.

**Delinquent Charges:** A debt is considered delinquent if it has not been paid within one month (30 calendar days) of the penalty due date or if a satisfactory payment arrangement has not been made. If the debt remains delinquent for more than 90 calendar days, a delinquent charge of six percent (6%) per annum will be assessed accruing from the date that the debt became delinquent.

**Administrative Costs:** Agencies of the Department of Labor are required to assess additional charges for the recovery of delinquent debts. These additional charges are administrative costs incurred by the Agency in its attempt to collect an unpaid debt. Administrative costs will be assessed for demand letters sent in an attempt to collect the unpaid debt.
