Purpose: This Instruction renews a Regional Emphasis Program (REP) for

construction operations having potential fall hazards.

EXECUTIVE SUMMARY

Workers employed in the construction industry face many hazards from falls that can lead to serious injury or death. Falls are the leading cause of death in construction. Construction work activities associated with the fatalities include, but are not limited to, work on elevated surfaces, work from scaffolding, work from aerial equipment, work from ladders, work conducted during demolition activities, construction of residential structures, construction of commercial and industrial structures, work conducted in a trench/excavation, work to construct, service, or repair overhead power lines, and work conducted on or near streets, roads, highways, bridges and overpasses for the purpose of building, maintaining or repairing them. Workers in construction may be exposed to fall hazards while working from ladders, scaffolds, roofs, communication towers, steel erection, or any other elevated workspace.

The intent of this Regional Emphasis Program is to encourage employers to take steps to address these hazards, ensure worksites are evaluated to determine if the employer is in compliance with all relevant OSHA requirements, and to help employers correct hazards, thereby reducing workers' potential injuries and deaths.

This REP has been in place for one year and outreach is a continual effort through programs such as Safety Fests and meetings with local industry organizations. Continued outreach activities will include training sessions with stakeholders, electronic information-sharing activities, public service announcements, and news release broadcasts. Enforcement activities will begin not earlier than three months after outreach is initiated and will include, but not be limited to, the inspection and review of construction activities that may include fall hazards; working conditions; injury and illness records; safety and health programs; and other potentially hazardous construction activities, to identify and obtain correction of workplace hazards at all applicable inspection sites.

- **Purpose**. This Instruction establishes a Regional Emphasis Program (REP), within the jurisdiction of Region X, to identify fall hazards and to prevent injuries and fatalities among workers in the construction industries.
- **II.** Action Offices. All Region X Area Offices and Office of Enforcement Programs.
- III. State Plan Impact. None.
- IV. Cancellation. None.
- V. <u>Expiration</u>: This Instruction will expire December 31, 2023, but may be renewed.
- VI. **Background.** This REP supports the DOL 2018-2022 Strategic Plan, Strategic Objective 2.1, to secure safe and healthy workplaces, particularly in high-risk industries. This REP will also address OSHA's FY 2019 Core Function of Enforcement to "Target the most hazardous worksites for inspection" and Performance Measure "OSHA -PG-01 Construction fatality rate decrease from baseline". Construction work activities associated with the fatalities include, but are not limited to, work on elevated surfaces, work from scaffolding, work from aerial equipment, work from ladders, work conducted during demolition activities, construction of residential structures, construction of commercial and industrial structures, work conducted in a trench/excavation, work to construct, service, or repair overhead power lines, and work conducted on or near streets, roads, highways, bridges and overpasses for the purpose of building, maintaining or repairing them. Falls are the leading cause of death in construction. Workers in construction may be exposed to fall hazards while working from ladders, scaffolds, roofs, communication towers, steel erection or any other elevated workspace. According to BLS data, in 2017 there were 355 fatal falls to a lower level out of 971 construction fatalities Nationwide, in 2017 there were 47,180 falls to lower level that resulted in one or more days away from work, including 10,950 falls to lower level in the construction industry. Thirty-five fatalities in the construction industry occurred in the four states within Region X between calendar years 2013 and 2018. This data was obtained from the BLS Fatal Occupational Injuries (CFOI) data and the OIS data.

VII. Procedures.

- A. <u>Outreach Program.</u> The Regional Office and each Area Office have conducted and will continue to provide outreach on fall hazards in the construction industry. Continued forms of outreach will be conducted. For example:
 - through forums such as governor's safety and health conferences and Safety Fests, the Area Offices will provide updated information to employers on topics such as the OSHA standards that apply; how to implement a safety and health program; and details about the REP.

- Area Offices will also discuss the Safe and Sound initiative during presentations or while attending professional conferences.
- information will be disseminated via the Boise Area Office electronic newsletter to employers and industry representatives.
- Area Offices will highlight this REP in their Annual Fall Stand Down activities.
- the Region X labor liaison, compliance assistance specialists, and Area Directors, will highlight the REP during their events with employers, professional associations and unions.
- when OSHA representatives attend speaking events, this REP will be discussed when appropriate.
- B. <u>Compliance Officer Training.</u> All compliance personnel shall be instructed on this procedure. Compliance personnel shall be instructed to report observed fall hazards to the Area Director.
- C. <u>Inspection Procedures</u>. Inspections shall be carried out at sites according to the policies and procedures in the Field Operations Manual (FOM). Inspections may be initiated when in-plain-view fall hazards are noticed during normal travels by the compliance officer (CSHO referral) or when formal complaints/non-formal complaints or other referrals are received. Inspection programming and scheduling lists are not utilized to identify inspection sites under this REP. When a compliance officer observes or receives any notice of a construction operation with fall hazards from elevations (including formal complaints/non-formal complaints, other government agency referrals, and reports from members of the public), the compliance officer shall document conditions as required by the FOM. If the worksite has not been inspected within the last 30 days, an inspection shall be conducted unless it is apparent that the site is in compliance with all OSHA standards governing such operations.

Construction operations having observable fall hazards brought to the attention of the area office shall be inspected as follows:

- 1. Formal complaints and referrals shall be inspected in accordance with the FOM. These inspections will be initiated within 5 working days.
- 2. Other complaints may be evaluated by the Area Director or supervisor prior to assignment and Area Directors may use their discretion whether or not to conduct an inspection or investigation.

- 3. An inspection assigned under this REP does not necessarily need to be inspected by the person making the original observation.
- 4. Documentation of the events leading up to the observation and reporting of the fall hazard(s) shall be maintained by the Area Office in case of denial of entry.
- 5. The compliance officer initially observing a fall hazard in-plain-view shall contact the Area Office supervisor or Area Director for a decision as to whether an inspection is required. However, if the compliance officer cannot reach the Area Director or supervisor at the time, an inspection shall be conducted and the supervisor informed as soon as practicable after the inspection is completed. The compliance officer may open an inspection when he/she observes employee exposures to fall hazards.
- 6. The scope of the inspections conducted under this REP shall normally be limited to the fall hazards and to serious hazards in the other three primary focus areas which are observed in-plain-view (i.e., electrical hazards, caught in or struck by hazards, and trenching hazards, as specified in the trenching NEP). Procedures in the FOM will be followed if the scopes of the inspections are to be expanded.

VIII. OIS Coding.

- A. Inspection record forms will be coded as follows:
 - 1. Inspection Type: Inspections shall be marked as programmed unless notification of a referral, complaint, fatality is received from outside sources which will be marked as unprogrammed.
 - 2. Local Emphasis Program: Mark as FALL.
- B. Compliance Activity Forms: Outreach activities more than 30 minutes in length will be recorded as a compliance assistance activity. Regional/Local Emphasis shall be coded as FALL.

IX. Evaluation.

This REP will be evaluated in accordance with the guidelines in Appendix A of CPL 04-00-002, *Procedures for Approval of Local Emphasis Programs*, dated November 13, 2018.

A. Each Area Director will be asked to provide input concerning special problems that may have surfaced during the year; recommendations to improve the REP; and recommendations to renew or not renew the REP.
